BOR RESOLUTION NO. 47, s. 2016

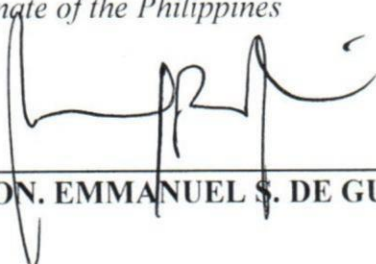

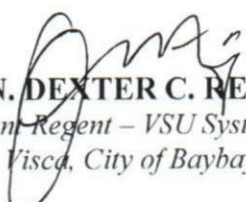

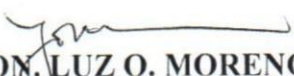
