BOR RESOLUTION NO. 27, s. 2009

A RESOLUTION APPROVING THE REVISION OF THE BACHELOR OF ELEMENTARY EDUCATION AND THE BACHELOR OF SECONDARY EDUCATION CURRICULA IN THE MAIN CAMPUS, EFFECTIVE 1st SEMESTER SY 2009-2010

WHEREAS, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to review and/or approval of the Board of Regents/Trustees through the President of the university or college*";

WHEREAS, the Philippine Association for Teacher Education (PAFTE) during its recent National Convention held last October 20-22, 2008 at Clark Field, Pampanga resolved that 1 unit of the 3 units on Special Topics shall be a course on Education for Peace, to train students for Peace while 2 units will be Elective Seminars on a range of topics chosen by the Teacher Education College;

WHEREAS, the PAFTE likewise strongly pushed for the offering of Educational Research in the Bachelor of Elementary Education (BEEd) and Bachelor of Secondary Education (BSEd) curricula;


WHEREAS, the University Academic Council met last 29 January 2009 on the occasion of the 21st UAC Meeting for the purpose of reviewing the proposal and has determined that the proposal is in line with the CHED requirement and has favorably recommended to the VSU Board of Regents the approval of the proposal;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the revision of the Bachelor of Elementary Education (BEEd) and the Bachelor of Secondary Education (BSEd) of the Main Campus pursuant to the initiatives undertaken by the PAFTE during its recent National Convention held last October 20-22, 2008 at Clark Field, Pampanga as well as CHED Memorandum Order No. 30, series of 2004, effective 1st Semester, SY 2009-2010.


