# A RESOLUTION APPROVING THE PROMOTION OF THREE (3) FACULTY MEMBERS PER RESULTS OF NBC 461–5<sup>TH</sup> CYCLE EVALUATION EFFECTIVE UPON RELEASE OF FUNDS FOR THE PURPOSE BY THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

**WHEREAS**, among the powers granted to the Board of Regents is the power to "fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the Visayas State University adheres to the results of the biennial NBC 461 evaluation of academic faculty which upgrades the positions of deserving academic faculty in accordance with their accomplishments covering a specific period;

WHEREAS, the following academic faculty have qualified for promotion based on their accomplishments and in accordance with the evaluation criteria set forth in the NBC 461 evaluation instrument, as follows:
