## BOR RESOLUTION NO. 44, s. 2008

## A RESOLUTIONAPPROVING THE INCREASE THE MONTHLY STIPEND OF VSU LABORATORY HIGH SCHOOL SCHOLARS

WHEREAS, the Visayas State University Laboratory High School (VSU-LHS) management has envisioned the "production of secondary basic education graduates, who are highly prepared and competitive for tertiary education":

WHEREAS, the VSU-LHS has identified that a key strategy for the attainment of such a vision is "to give monetary incentive in the form of scholarships or grants to those who excel in their academic performance";

WHEREAS, in consideration of the rising cost of basic consumer goods, the present benefits enjoyed by VSU-LHS academic scholars "are no longer attractive to the qualified students";

WHEREAS, the VSU-LHS management has observed that "a number of exceptional incoming qualified students prefer to enroll in favor of other institutions because of better scholarship benefits";

WHEREAS, the VSU-LHS management has found it necessary to propose the increase in the monthly stipends of qualified VSU-LHS academic scholars to be able to attract high quality high school students into the Laboratory School; and

WHEREAS, the University Administrative Council (UAdCo) on the occasion of its 71<sup>st</sup> Meeting dated 27 May 2008 took up, approved and recommended to the Board of Regents the approval of this proposal.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed increase in monthly stipend of qualified VSU-LHS scholars, as proposed, effective 1<sup>st</sup> Semester SY 2008-2009.
