**BOR RESOLUTION NO. 31, s. 2016**

**A RESOLUTION APPROVING THE REQUEST FOR AUTHORITY TO UTILIZE THE  
GENERAL FUND CAPITAL OUTLAY CHARGED UNDER CONSTRUCTION, REPAIR  
AND REHABILITATION OF ACADEMIC BUILDINGS *SUBJECT TO EXISTING  
POLICIES, RULES AND GUIDELINES ON THIS MATTER***

**WHEREAS**, Republic Act No. 10717 otherwise known as the General Appropriations Act of 2016 include fund allocations for Capital Outlay projects of the University;

**WHEREAS**, the GAA funds for Capital Outlay are subdivided into: For Comprehensive Release (FCR) and For Later release (FLR);

**WHEREAS**, on 11 February 2016, the Department of Budget and Management (DBM) Region 8 issued an advisory pertaining to some items under FLR as follows:

**WHEREAS**, a Special Allotment Order (SARO) is no longer issued for funds included under FCR but funds included under FLR still require a SARO prior to its release;

**WHEREAS**, one of the requirements for the release of the SARO for FLR funds is a resolution from the Governing Board endorsing the utilization of the said fund;

**WHEREAS**, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board *"to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University"*;

**WHEREAS**, the proposal was discussed and approved on the occasion of the 118<sup>th</sup> UADCO Meeting held last 13 June 2016 at Office of the Vice President for Administration and Finance, 2<sup>nd</sup> Floor, Administration Building, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the request for authority to utilize the General Fund Capital Outlay charged under Construction, Repair and Rehabilitation of Academic Buildings *subject to* existing policies, rules and guidelines on this matter.
