**BOR RESOLUTION NO. 125, s. 2016**

**A RESOLUTION APPROVING THE APPOINTMENT OF DR. SANTOS B. VILLOCINO TO A PERMANENT POSITION IN THE VSU MAIN CAMPUS *SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS***

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to fix and adjust salaries of faculty members and administrative officials and employees ...*" as stipulated in Section 7, Item (h) of R.A. 9158;

**WHEREAS**, Dr. Santos B. Villocino was formerly a faculty member holding permanent position at the Northwestern Samar State University (NWSSU), Calbayog City, Western Samar;

**WHEREAS**, Dr. Santos B. Villocino applied for a position with the Department of Horticulture, College of Agriculture, Visayas State University-Main Campus VSU Main Campus, Visca, City of Baybay, Leyte;

**WHEREAS**, the Department of Horticulture has decided to accept Dr. Santos B. Villocino's application to be a faculty of the Department;

**WHEREAS**, the Academic Personnel Board (APB) of the Visayas State University, undertook a process of screening the qualifications and background of Dr. Santos B. Villocino and is recommending that he be accepted into the VSU Main Campus with a Permanent item and is endorsing the same to the VSU Board of Regents for Confirmation *subject to* existing rules, regulations and guidelines governing such appointments.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to confirm the appointment status of Dr. Santos B. Villocino to a permanent position in the VSU Main Campus, effective on the date indicated.




