**A RESOLUTION APPROVING THE NON
RECLASSIFICATION TO ASSOCIATE PROFESSOR ACADEMIC RANKS OF SEVEN (7)
VISAYAS STATE UNIVERSITY (VSU) FACULTY MEMBERS FOR THE REASON OF NON-
COMPLETION OF DOCTORAL DEGREES, NO PUBLICATION IN REPUTABLE PEER
REVIEWED JOURNALS AND LEGITIMATE COPYRIGHTED WORKS, AND NO
ADMINISTRATIVE DESIGNATIONS WITH ASSISTANT PROFESSOR IV AS THE
FALLBACK ACADEMIC RANK**

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board *"to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University"*;

WHEREAS, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

WHEREAS, it is the exclusive power of the University's Board of Regents to approve/grant promotions of the faculty members of the university;

WHEREAS, seven (7) faculty members of Visayas State University failed to complete their Doctoral Degrees until the present;

WHEREAS, the seven (7) faculty members also failed to publish journal articles as outputs of their research in reputable peer reviewed journals and have not also served in any administrative position in the university;

WHEREAS, a faculty member whose CCE and QCE points qualifies him/her to the Associate Professor Rank is only allowed to cross to the Associate Professor rank only if he/she is a holder of a relevant Doctoral Degree or has served in an administrative position or has published a journal article in a reputable peer-reviewed journal or other legitimate copyrighted works;

RESOLVED AS IT IS THEREBY RESOLVED to approve the non-reclassification to Associate Professor Academic Ranks of seven (7) VSU faculty members for the reason of non-completion of Doctoral Degrees, no Publication in reputable peer-reviewed journals and other legitimate copyrighted works, and no administrative designations with Assistant Professor IV as the Fallback Academic Rank


