**A RESOLUTION APPROVING THE
AMENDMENT OF THE GRADUATE SCHOOL CODE**

WHEREAS, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board “to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils as hereby provided;

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council – stipulates the powers of the Academic Council to wit: “to review and recommend the curricular offerings...of the University or college for appropriate action by the Board of Regents/Trustees...through the President of the university or college”;

WHEREAS, Item a of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 empowers the Academic Council to: “Determine, review and recommend for the approval of the Governing Board the course offerings of the concerned chartered SUC and submit the same to its GB for review and/or approval accordance with Section 4, Paragraph (i) of R.A. 8292;


WHEREAS, the University Academic Council of the Whole met last 12 February 2008 for the purpose of reviewing the proposal to amend the Graduate School Code specifically Article II, Section 3.2c and Article VII, Sec. 15.1 and found the proposal to be in order and has recommended the proposal to the VSU Board of Regents for approval;


