BOR RESOLUTION NO. 118, s. 2020

A RESOLUTION COURSED THROUGH REFERENDUM APPROVING THE REVISED ACADEMIC CALENDAR FOR SY 2020 - 2021

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001, which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (a) of R.A. 9158 empowers the Governing Board "to enact rules and regulations as may be necessary to carry out the purposes and functions of the University";

WHEREAS, the VSU Board of Regents (BOR) approved the revised VSU Academic Calendar for SY 2020 – 2021 during the 98th BOR Meeting last 19 August 2020 after taking into consideration the changes needed in the light of the COVID-19 pandemic;

WHEREAS, Section 10 of R.A. 9158 indicates that it is the duty of the Administrative Council "to review and recommend to the Board policies governing the administration, management and development planning of the University";

WHEREAS, the Visayas State University needs to program its most important academic activities for the incoming school year with the implementation of a flexible learning system in response to the COVID-19 pandemic;

WHEREAS, the proposed revision of the Academic Calendar for SY 2020 – 2021 was presented for discussion to the University Administrative Council (UADCO) on the occasion of the 139th UADCO Meeting held last 24 August 2020 via teleconference;

WHEREAS, the UADCO approved the proposed revision of the Academic Calendar for SY 2020 – 2021 as presented, and is strongly endorsing the same to the VSU Board of Regents for **Approval**;

WHEREAS, the University President has reviewed the proposed Academic Calendar for SY 2020 – 2021 and is endorsing the same to the Board of Regents for **Approval**;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to **Approve** the Revised Academic Calendar for SY 2020 – 2021 as proposed.
