**A RESOLUTION APPROVING
THE INCREASE IN THE CONSULTANCY FEE/RETAINER
OF ATTY. GLORIOSA CAYUNDA-GUINOCOR
UNIVERSITY LEGAL CONSULTANT**

WHEREAS, the Leyte State University has solicited the professional services of Atty. Gloriosa Cayunda-Guinocor as Legal Counsel/Consultant since 2000;


WHEREAS, the Office of the Solicitor-General has deputized Atty. Gloriosa Cayunda-Guinocor as Special Attorney of the Office of the Solicitor General for the period 01 January 2006 until 31 December 2006 as contained in its reply to the request fo the Office of the University President dated 06 January 2006;

WHEREAS, Atty. Gloriosa Cayunda-Guinocor has accepted the duties and responsibilities attendant to the position;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposal to Increase the Consultancy Fee/Retainer of Atty. Gloriosa Cayunda-Guinocor, LSU Legal Counsel/Consultant from P5,000.00 to P10,000.00 per month effective 01 January 2006 until 31 December 2006 plus actual transportation, food, lodging and other incidental expenses whenever required to travel outside of LSU. Furthermore, Atty. Gloriosa Cayunda-Guinocor will still continue to receive P5,000.00 per case payable after ecery decision promulgated by a competent court, P500.00 per court appearance, and P500.00 appearance fee everytime she is invited to attend BOR meeting.
