**A RESOLUTION CONFIRMING

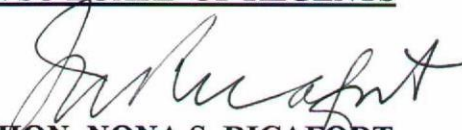

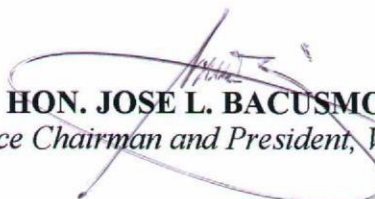

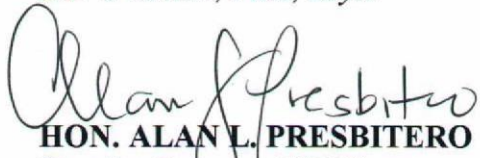
