BOR RESOLUTION NO. 206, s. 2018

A RESOLUTION DENYING THE REQUEST OF WINSTONBUILT INDUSTRIES, R.S. REYNA CONSTRUCTION, AND LINMAR CONSTRUCTION FOR REPLACEMENT OF FLOOR TILES FROM MARIWASA TO GRANITE IN THE ON-GOING CONSTRUCTIONS (PHASE 2) OF THE TWO-STOREY ACADEMIC BUILDINGS IN VSU ALANGALANG, VSU ISABEL, AND VSU TOLOSA RESPECTIVELY

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, the Visayas State University advertised the Invitation to Apply for Eligibility and to Bid for the Projects: "Construction of Two-Storey Academic Buildings, Phase 2, for VSU Alangalang, VSU Isabel, and VSU Tolosa in the PhilGEPS, VSU Website's Transparency Seal, and in conspicuous places within the premises of the Visayas State University for twenty-one (21) calendar days;

WHEREAS, the contracts of the aforementioned projects in VSU Alangalang, VSU Isabel, and VSU Tolosa were awarded to: Winstonbuilt Industries, R.S. Reyna Construction, and Limar Construction, respectively;

WHEREAS, the BAC received requests from Contractors for replacement of the specifies floor tiles from Mariwasa to Granite allegedly due to limited stocks in the market;

WHEREAS, the BAC assigned the BAC Secretariat to check the alleged scarcity of Mariwasa tiles in the market;

WHEREAS, the BAC met last 25 September 2018 to discuss and review the requests of the contractors and hear the results of the market assessment conducted by the BAC Secretariat;

WHEREAS, the Technical Working Group mentioned the disadvantages of the Granite tiles;

WHEREAS, the BAC Secretariat reported that Mariwasa tiles to be now available in the market;


WHEREAS, the proposal was discussed and approved by the BOR Finance Committee during its Quarterly Meeting held last 23 November 2018 at the Samal Room, NEDA Regional Office VIII, Government Center, Palo, Leyte;


