BOR RESOLUTION NO. <u>68</u> Series of 2025

CONFIRMING THE NOTICES OF AWARD AND CONTRACTS ISSUED BY THE UNIVERSITY PRESIDENT TO WINNING BIDDERS FOR VARIOUS GOODS AND INFRASTRUCTURE PROJECTS, COVERING THE PERIOD JANUARY TO MARCH 2025.

WHEREAS, BOR Resolution No. 121, series of 2024, granted the University President of Visayas State University the authority to approve and enter into contracts involving goods and infrastructure projects, subject to existing government procurement laws and policies;

WHEREAS, BOR Resolution No. 157, series of 2024, further authorized the University President to sign contract agreements, issue Notices of Award, and Notices to Proceed for infrastructure and equipment projects with a contract amount not exceeding ten million pesos (PHP 10,000,000.00) and for expendable goods and services with a contract amount not exceeding six million pesos (PHP 6,000,000.00) per contract;

WHEREAS, Republic Act No. 9184, or the Government Procurement Reform Act, particularly Section 7, mandates that the procurement of goods and infrastructure projects must conform to the University's duly approved Annual Procurement Plan (APP) and must follow transparent, competitive, and accountable processes;

WHEREAS, pursuant to the delegated authority, and based on the recommendations of the University's Bids and Awards Committee (BAC), the University President issued Notices of Award and executed contracts with winning bidders for various projects involving goods and infrastructure, all of which followed the prescribed public bidding procedures and threshold requirements;

WHEREAS, the contracts awarded cover essential procurement for the operational and developmental needs of the University, ensuring timely and lawful implementation in support of institutional goals;

WHEREAS, all contracts entered into by the University President pursuant to this delegated authority shall be submitted to the Board of Regents for confirmation during its regular meeting;

WHEREAS, the University Administrative Council (UADCO), during its meeting on February 14, 2025 at the RDE Hall, endorsed the list of awarded contracts for confirmation by the Board of Regents;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED, that the Board of Regents confirms the Notices of Award and contracts issued by the University President to the winning bidders for various goods and infrastructure projects, as listed in the attached document;


