**WHEREAS**, sabbatical assignment is granted to qualified members of the faculty to encourage study, investigation, research and to improve staff competencies for improved efficiency;

**WHEREAS**, Dr. Julie D. Tan, Professor VI, Visayas State University – Main Campus, has expressed her desire to write two (2) Practical Guides and submit one publishable material in a refereed journal as outputs of the Sabbatical Leave;


