PATINDOL, VP FOR ADMINISTRATION AND FINANCE AS OFFICER-IN-CHARGE OF THE VISAYAS STATE UNIVERITY FOR THE DURATION OF THE PRESIDENT'S TRAVEL TO JAPAN FROM 22 JANUARY 2017 UNTIL 28 JANUARY 2017 SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING POWERS THAT MAY BE EXERCISED BY AN OFFICER-IN-CHARGE

WHEREAS, Dr. Remberto A. Patindol, Vice-President for Administration and Finance, has been designated by the University President, Dr. Edgardo E. Tulin, to be the Officer-In-Charge of the Visayas State University for the duration of his travel to Japan from 22-28 January 2017.

Patindol be designated as Officer-In-Charge of the University for the duration of the University President's travel to Japan this coming 22-28 January 2017 *Subject to* existing rules and regulations governing powers that may be exercised by an Officer-In-Charge.
