### **BOR RESOLUTION NO. 70, s. 2007**

**Approving the Appointment of  
DR. JOSE L. BACUSMO  
as President of the Visayas State University**

**WHEREAS**, Section 28 of the Implementing Rules and Regulations (IRR) of Republic Act 8292, as embodied in CHED Memorandum Order No. 03, Series of 2001 stipulate "Presidents of chartered SUCs appointed under this IRR shall be eligible for re-appointment for another term only";

**WHEREAS**, Dr. Paciencia P. Milan has already served two (2) consecutive terms as President of the Visayas State University (VSU) ending last September 30, 2007;

**WHEREAS**, the VSU Board of Regents created a Search Committee for the Presidency (SCP) in compliance with the Section 22 of CHED Memorandum Order No. 3, s. 2001;

**WHEREAS**, the SCP undertook the recruitment and screening of applicants for the Presidency as mandated in Section 23 of CHED Memorandum Order No. 3, s. 2001;

**WHEREAS**, pursuant to Section 24 of CHED Memorandum Order No. 3, s. 2001, the SCP submitted to the VSU Board of Regents the names of all the candidates;

**WHEREAS**, the SCP reported to the VSU Board of Regents the strengths and weaknesses of each candidate;

**WHEREAS**, the VSU Board of Regents interviewed the three (3) candidates and after the interview cast their respective votes for President;

**WHEREAS, DR. JOSE L. BACUSMO**, Vice-President for Academic Affairs of the Visayas State University, Visca, City of Baybay got the most number of votes.


**THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to approve the appointment of **DR. JOSE L. BACUSMO** as **University President** of the Visayas State University effective 01 November 2007 until 31 October 2011 in accordance with Section 27 of CHED Memorandum Order No. 3, s. 2001.




