BOR RESOLUTION NO. 37, s. 2019

**A RESOLUTION CONFIRMING THE MEMORANDUM OF AGREEMENT
ENTERED INTO BY THE VISAYAS STATE UNIVERSITY (VSU)
AND THE STITCHING STAGIAIRES CEBU (SSCEBU)**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power “to develop consortia and other forms of linkages with local governments, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University” as stipulated in Section 7, Item (s) of R.A. 9158;

WHEREAS, there is a need to expose selected VSU students enrolled in the Bachelor of Science in Agriculture (BSA) *major* in Horticulture to various modern agricultural standards, methods and technologies;

WHEREAS, the Stitching Stagiaires Cebu (SSCebu), a Foundation with principal office at Spiering Weg 1000 2136 LL Zwaanshoek, The Netherlands, provides a program of advanced studies and training in various fields in agriculture in Holland for students enrolled in selected Universities in the Philippines;

WHEREAS, the SSCebu has the capability and the capacity to provide the needed on-the-job agricultural training to the students of VSU to enhance the students’ theoretical education and practical skills as indicated in the MOA;

WHEREAS, the Governing Board, is convinced that the MOA entered into by and between the VSU and the SSCebu is imbued with public interest and contributes to the stock of knowledge needed for the advancement of science and understanding.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the Memorandum of Agreement entered into by and between the Visayas State University and the Stitching Stagiaires Cebu (SSCebu).
