A RESOLUTION APPROVING THE REQUEST OF PRESIDENT EDGARDO E. TULIN FOR AUTHORITY TO TRAVEL TO THE JAPAN FOR THE PERIOD 8 OCTOBER 2016 UNTIL 14 OCTOBER 2016 *SUBJECT TO EXISTING RULES AND REGULATIONS GOVERNING FOREIGN TRAVELS BY GOVERNMENT OFFICIALS*

WHEREAS, the University President, Dr. Edgardo E. Tulin would like to visit the Tokyo University of Agriculture and Technology (TUAT), Koganei-shi, Tokyo, Japan to sustain the collaboration between TUAT and VSU;

WHEREAS, President Tulin likewise intends to strengthen the Short-Term Exchange Program (STEP) in Science and Engineering so that VSU can be included in the exchange program;

WHEREAS, the Asian Association of Agricultural Colleges and Universities (AAACU) will be having its Biennial Conference and General Assembly this coming 10-13 October 2016 at the Tokyo University of Agriculture, Setagaya, Tokyo, Japan:

WHEREAS, Section 7(t) of R.A. 9158 specifically empowers the VSU Board of Regents to "*develop academic arrangements for institutional capability building with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/specialists as consultants, or visiting or exchange professors, scholars, researchers, as the case may be*";


WHEREAS, the AAACU has indicated that it will shoulder the local and international airfares as well as the board and lodging expenses while in Japan.


NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED to Approve the request of President Edgardo E. Tulin for authority to travel to Japan for the period 8-14 October 2016 *subject to existing rules and regulations governing foreign travels by government officials.*
