**A RESOLUTION CONFIRMING  
THE APPOINTMENTS OF SOME UNIVERSITY  
PERSONNEL TO DESIGNATED ADMINISTRATIVE POSITIONS  
EFFECTIVE ON THE DATES INDICATED UNTIL 31 DECEMBER 2012  
SUBJECT TO EXISTING AUDITING RULES, REGULATIONS

**WHEREAS**, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board *"to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University"*;

**WHEREAS**, the University needs to periodically assess the efficiency and effectiveness in the delivery of its services to its clientele;

**WHEREAS**, the University has found it necessary to restructure its Organizational Structure to enable the University to be more responsive to the needs of its clientele;


**WHEREAS**, in the course of the University restructuring, it was necessary to create new designated positions which necessitated the reshuffling of university personnel including some faculty members designated to key administrative positions;






