A RESOLUTION APPROVING THE OFFERING OF AGRICULTURE COURSES IN ORMOC CITY

WHEREAS, the Viasyas State University – Main Campus, currently is the only fourth (4th) level accredited university in the Eastern Visayas and is also has a Level 3 AACCUP accredited agriculture education system;

WHEREAS, the University's core functions are Instruction, Research, Extension and Production;

WHEREAS, the mandate of the University covers the whole country with special interest in areas with good agricultural potential;

WHEREAS, the Governing Board (GB) is authorized under Section 7, Item (u) of R.A. 9158 to "set-up adoption of modern and innovative modes of transmitting knowledge such as the use of information technology, the dual system open-learning, community laboratory, etc..., for the promotion of greater access to higher education";

WHEREAS, the Honorable Mayor of the City of Ormoc, Leyte, Hon. Eric C. Codilla, has sought the assistance of the University insofar as establishing an "instructional extension service" of the University's agriculture degree programs within Ormoc City;

WHEREAS, the University is the only university within a 100 kilometer radius, with a proven complement of agricultural experts who can provide the establishment of an "instructional extension service in agriculture" within Ormoc City; and

WHEREAS, GB after careful study and discussion of the request, has determined that the request is meritorious and urgent.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the establishment of an "instructional extension service" of the University's agriculture degree programs, within Ormoc City, Leyte, *Provided That*, all costs attendant to the offering of this "instructional extension service" will be borne by the Requesting Party.
