**BOR RESOLUTION NO. 60, s. 2008**

**A RESOLUTION APPROVING  
THE INCREASE IN ATHLETIC FEES FROM  
SEVENTY PESOS TO ONE HUNDRED FIFTY PESOS  
EFFECTIVE 2<sup>nd</sup> SEMESTER, SCHOOL YEAR 2008-2009**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to fix the tuition fees and other necessary school fees and charges such as, but not limited to, matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultations with the involved sectors*" as stipulated in Item (d), Section 7 of R.A. 9158;


**WHEREAS**, there is a need to increase the Athletic Fees charged to students in view of the increasing cost of sustaining the University's athletic programs including athletic supplies and sports equipment;

**WHEREAS**, the University Administrative Council unanimously approved the increase in Athletic Fees from P70.00/student/semester to P150.00/student/semester effective in the 2<sup>nd</sup> Semester, School Year 2008-2009 during the 72<sup>nd</sup> UADCO Meeting held last 19 September at the 2<sup>nd</sup> Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the increase in Athletic Fees from P70.00/student/semester to P150.00/student/semester effective in the 2<sup>nd</sup> Semester, School Year 2008-2009.
