BOR RESOLUTION NO. 44, s. 2015

A RESOLUTION CONFIRMING THE RANK OF MR. NELLO D. GORNE AS ASSISTANT PROFESSOR I BASED ON HIS NBC 461, $5^{\rm TH}$ CYCLE PRINT OUT WHILE AT CARAGA STATE UNIVERSITY AND EFFECTIVE ON THE DATE INDICATED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, among other powers granted to the Board of Regents is the power "to appoint, upon recommendation of the President, ... and other officials and employees of the University" as stipulated in Section 7, Item (g) of R.A. 9158;

WHEREAS, the University regularly promotes academic staff whenever there are vacancies brought about by retirement of personnel;

WHEREAS, Mr. Nello D. Gorne, while employed at the Caraga State University, qualified for the position of Assistant Professor I as attested by his NBC 461, 5th Cycle printout;

WHEREAS, upon the transfer of Mr. Gorne to the Visayas State University, the VSU Academic Personnel Board, in its 20 January 2015 meeting recommended that Mr. Gorne be likewise given an equivalent rank of Assistant Professor I;

WHEREAS, the Department of Budget and Management (DBM) provides for the upgrading of the qualified faculty member *provided that* said faculty is endorsed by the Governing Board; and

WHEREAS, the Human Resource Development Office (HRDO) and the University Academic Personnel Board (APB) are strongly recommending that Mr. Nello D. Gorne be given an equivalent rank of Assistant Professor I.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the grant of an equivalent position of Assistant Professor I on Mr. Nello D. Gorne, effective on the date indicated.
