**A RESOLUTION APPROVING  
THE PROPOSAL TO INCREASE SOME  
FEES OF THE VSU LABORATORY HIGH SCHOOL  
EFFECTIVE SY 2011-2012 *SUBJECT TO EXISTING RULES,*  
REGULATIONS AND GUIDELINES GOVERNING THE INCREASE  
IN MATRICULATION FEES**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to fix the tuition fees and other necessary school fees and charges, such as, but not limited to, matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultation with the involved sectors*" as stipulated in Section 7, Item (d) of R.A. 9158;

**WHEREAS**, Section 7, Paragraph (f) of R.A. 9158 provides, "*to authorize the construction or repair of its buildings, machineries, equipment ...*"

**WHEREAS**, the infrastructure facilities of the University's Laboratory High School had been in existence for the past 50 years and the cost of maintaining these infrastructures, to make it safe for both students and faculty, has been spiraling the past few years;

**WHEREAS**, it is a fact that the university is unable to fund the repairs of these buildings because the University's budget for repairs and maintenance is not even sufficient for the upkeep of the University's main buildings and facilities;

**WHEREAS**, it is for this reason that the parents of the high school students should be made to help support the upkeep and maintenance of the buildings and facilities of the Laboratory High School in the light of present day realities especially the declining government budget for MOOE.

**WHEREAS**, the proposal was presented and discussed during the 89<sup>th</sup> University Administrative Council and the proposal was approved as evidenced by the passage of UADCO Resolution No. 6, s. 2011 dated 14 April 2011.

**WHEREAS**, the Governing Board is convinced of the merit of the proposal.



**RESOLUTION APPROVING THE IMPOSITION OF A P1,000.00 FACILITIES DEVELOPMENT FEE OF  
VISAYAS STATE UNIVERSITY-LABORATORY HIGH SCHOOL, EFFECTIVE SY 2011-2012**

**WHEREAS**, the Visayas State University is determined to provide quality secondary education through the Visayas State University-Laboratory High School (VSU-LHS);

**WHEREAS**, the facilities used by the VSU-LHS are VSU facilities that were mostly constructed about 50 years ago or more;

**WHEREAS**, the Parent-Teacher Association (PTA) of VSU-LHS recognize the danger posed by these buildings to the students if repairs and renovation of these buildings will not be undertaken;

**WHEREAS**, the PTA of VSU-LHS understands that further improvement of the quality of education will be experienced and acquired by the students if VLHS will have better facilities;

**WHEREAS**, the PTA of VSU-LHS and VSU administration have agreed to embark on a long-term development of the facilities of the VSU-LHS;

**WHEREAS**, the PTA of VSU-LHS have unanimously approved and endorsed to the VSU Board of Regents the imposition of a facilities development fee of One Thousand Pesos Only (P1,000.00) effective SY 2011-2012;


**WHEREAS**, the assessment will be paid to VSU and VSU will create a fiduciary trust fund account for the purpose stated above;






