BOR RESOLUTION NO. 1, s. 2014

A RESOLUTION APPROVING BY REFERENDUM THE REQUEST OF VSU ADMINISTRATION TO GRANT CALAMITY RELIEF ASSISTANCE IN THE AMOUNT OF FIFTEEN THOUSAND PESOS (P15,000.00) TO ALL EMPLOYEES OF THE VISAYAS STATE UNIVERSITY SYSTEM

- WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;
- **WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";
- **WHEREAS**, Section 7 (b) of R.A. 9158 authorize the Governing Board to "Receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";
- **WHEREAS**, Typhoon Yolanda hit the Eastern Visayas last 08 November 2013 and devastated a huge portion of the Province of Leyte;
- **WHEREAS**, the Office of the President of the Philippines issued Proclamation No. 682, s. 2013 dated 11 November 2013 declaring a State of National Calamity in response to the widespread death, destruction and incalculable damage caused by Typhoon Yolanda in the Visayas including the Province of Leyte which bore the brunt of the typhoon;
- **WHEREAS**, the purpose of the declaration of a State of National Calamity will be to hasten the rescue, recovery, relief and rehabilitation efforts of the government and the private sector, including any humanitarian assistance;
- **WHEREAS**, VSU is in a position to provide Calamity Relief Assistance to its employees in the amount of **FIFTEEN THOUSAND PESOS** (*P15*,000.00) each charged to savings (*STF Fund 164*) for 2013:
- WHEREAS, the Governing Board is convinced that the request is most beneficial to the interests of the University;
- THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the request to VSU Administration for the grant of Calamity Relief Allowance to all employees of the VSU-system charged to savings (STF Fund 164) for 2013.

PROCLAMATION NO. 682

DECLARING A STATE OF NATIONAL CALAMITY

WHEREAS, Typhoon Yolanda (international codename: Haiyan) caused widespread death, destruction and incalculable damage in several areas, including the Samar provinces, Leyte, Cebu, Iloilo, Capiz, Aklan and Palawan;

WHEREAS, in accordance with Republic Act No. 10121, or the Philippine Disaster Risk Reduction and Management Act of 2010, the National Disaster Risk Reduction and Management Council (NDRRMC) has recommended the declaration of a State of National Calamity;

WHEREAS, the declaration of a State of National Calamity will hasten the rescue, recovery, relief, and rehabilitation efforts of the government and the private sector, including any international humanitarian assistance; and

WHEREAS, this declaration will, among others, effectively control the prices of basic goods and commodities for the affected areas and afford government ample latitude to utilize appropriate funds for rescue, recovery, relief, and rehabilitation efforts of, and to continue to provide basic services to, affected populations, in accordance with law.

NOW, THEREFORE, I, BENIGNO S. AQUINO III, President of the Philippines, by virtue of the powers vested in me by the Constitution and by law, do hereby declare a State of National Calamity.

All departments and other concerned government agencies are hereby directed to implement and execute rescue, recovery, relief, and rehabilitation work in accordance with pertinent operational plans and directives.

All departments and other concerned government agencies are also hereby directed to coordinate with, and provide or augment the basic services and facilities of, affected local government units.

Law enforcement agencies, with support from the Armed Forces of the Philippines, are directed to undertake all necessary measures to ensure peace and order in affected areas, as may be necessary.

The State of National Calamity shall remain in force and effect until lifted by the President.
