WHEREAS, the VISAYAS STATE UNIVERSITY through its Bids and Awards Committee posted on 4 February 2020 in the PhilGEPS, VSU Website's Transparency Seal and in conspicuous places within the premises of the Visayas State University an Invitation to Bid for the **Supply and Delivery of Technical and Scientific Equipment for PhilRootcrops – II Rebid (GOODS – 20 -12) for a total value of Six Million Eight Hundred Sixty-Five Thousand Pesos (Php 6,865,000.00)**

WHEREAS, the source of funds was from General Fund and allotted for the Project entitled "Innovation and Advanced Technology Program for Region VIII;

WHEREAS, only a single bidder offered a bid during the opening of bid on 26 February 2020:
Baybay Printshop;

WHEREAS, Baybay Printshop offered a bid to deliver and supply three (3) units of Multicopter with D-RTK 2 GNSS Mobile Station Combo with carrying case at a unit cost of Php 900,000.00 against the ABC of Php 950,000.00;

WHEREAS, furthermore Baybay Printshop to deliver and supply 25 pieces of Multicopter Intelligent Flight Battery at a price per piece of Php 14, 500.00 against the ABC of Php 15, 000.00;

WHEREAS, no bidder offered to deliver and supply Item No. 3 – 2 units of Vertical Take Off and Landing UAV with software with carrying case and Item No. 4 – 2 units of Mutispectral Camera Sensor against the per unit ABC of Php 1, 500,000.00 and Php 320,000.00, respectively;

WHEREAS, both Items No. 3 and 4 should now be procured through Alternative Method: Negotiated Procurement – Two Failed Bidding;

NOW, THEREFORE, based on the above premises, we the Members of the Bids and Awards Committee, **HEREBY RESOLVE**, as it is **RESOLVED** to:



1. Declare Baybay Printshop as the bidder with the Single/Lowest Calculated Responsive Bid for Item No. 1 – Multicopter with D-RTK 2 GNSS Mobile Station Combo with carrying case valued at a Php 900,000.00 per unit for a total value of Two Million Seven Hundred Thousand Pesos (Php 2, 700,000.00);
2. Declare Baybay Printshop to deliver and supply 25 pieces of Multicopter Intelligent Flight Battery at a price per piece of Php 14,500.00 for a total value of Three Hundred Sixty-Two Thousand Five Hundred Pesos (Php 362,500.00);
3. Recommend to the HOPE, the Board of Regents the approval to award the contract to the winning bidder the respective Items;
4. Declare the failure of bidding for Item No. 3 - Vertical Take Off and Landing UAV with software with carrying case and Item No. 4 - Mutispectral Camera Sensor;
5. Recommend to the HOPE, the Board of Regents, to approve the procurement of Items No. 3 and 4 through Negotiated Procurement- Two Failed Bidding.
