### BOR RESOLUTION NO. 43, s. 2011

WHEREAS, the UAC passed UAC Referendum No. 1, s. 2011 dated 03 June 2011 strongly endorsing the list of candidates for graduation from the Main Campus and the Villaba Campus to the VSU Board of Regents for Confirmation, *Provided That*, all the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2010-2011.
