**BOR RESOLUTION NO. 42, s. 2009**

**A RESOLUTION APPROVING  
THE PURCHASE OF A BRAND NEW  
DOUBLE CAB VEHICLE IN SUPPORT OF THE  
OPERATIONS OF THE COLLEGE OF INDUSTRIAL  
TECHNOLOGY AND ENGINEERING (CITE), VSU ISABEL**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University*" as stipulated in Item (b), Section 7 of R.A. 9158;

**WHEREAS**, the College of Industrial Technology and Engineering (CITE), VSU Isabel has determined that bringing in money for employee salaries by the College Cashier from Ormoc City poses a very critical security risk to said employee endangering her life as well as the benefits of the employees of the College;

**WHEREAS**, the CITE has set aside the amount of P1,500,000.00 for the sole purpose of purchasing a brand new double cab vehicle that will be used by the College primarily for withdrawing money from Ormoc City as well as for other Official Trips;


**WHEREAS**, the College Accountant has certified that the said amount to be used is sourced from Savings from the Special Trust Fund (STF) 164.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the purchase of a brand new double cab vehicle sourced from the Special Trust Fund (STF) 164 of the College, *Provided. That*, the cost of the vehicle shall not exceed P1,500,000.00, the amount allocated for this purpose.




