KNOW ALL MEN BY THESE PRESENTS:

This Agreement entered into by and between:

The VISAYAS STATE UNIVERSITY, an institution of higher fearning established under Presidential Decree No. 470 as amended by Presidential Decree No. 700 and converted into a state university by virtue of Republic Act No. 9158 and renamed as Visayas State University by virtue of Republic Act No. 9437, with principal office at Baybay City, Leyte, duly represented by its President DR. PROSE IVY G. YEPES, hereinafter referred to as the FIRST PARTY;

<u>Genran Longos Labra</u>, of legal age, Single/Married, Filipino and with residence and postal address at <u>Fatima</u>, <u>Liloan</u>, <u>Southern Leyte</u> hereinafter referred to as the <u>SECOND PARTY</u>;

## WITNESSETH:

WHEREAS, the **FIRST PARTY** is in need of persons who can provide administrative support services which cannot be performed by the existing regular manpower/employees of the specific units/departments/centers within the university;

WHEREAS, the **SECOND PARTY**, possesses the required qualification and expertise needed by the hiring department/center/unit/office and is willing to provide the services needed;

NOW, THEREFORE, premises considered, the parties hereto hereby agree as they have agreed under the terms and conditions, as follows:

THE FIRST PARTY hereby contract the services of the SECOND PARTY as <u>PROJECT</u> TECHNICAL AIDE V to perform the following functions as follows:

- 1. Supports the team with technical work such as field visits, inspections, and data collection
- 2. Helps ensure project activities follow approved standards and guidelines
- 3. Prepares technical reports and maintain accurate records of field activities and project progress
- 4. Assists in coordinating with partner groups, communities, and other stakeholders to address technical issues
- 5. Reports any challenges or risks observed during implementation
- 6. Helps monitor project activities and ensure they meet technical requirements
- 7. Stays informed about relevant policies, standards, and good practices
- 8. Performs other related tasks as assigned to support the success of the project.

THAT when the work demand for travel, the **SECOND PARTY** shall be entitled to payment of travel expenses (per diem and fare) when traveling on official business within the country subject to existing government accounting rules and regulations and to pertinent VSU policies and rules governing official travel.

THAT for and in consideration of the foregoing service, the FIRST PARTY binds itself to pay each SECOND PARTY in the amount of TWENTY-FIVE THOUSAND SEVEN HUNDRED THIRTY-EIGHT PESOS (\$\mathbb{P}25,738.00)\$ per month inclusive of premium at not less than 8 hours per day based on the work schedule as prescribed by the hiring department/office/center/unit;

The **SECOND PARTY** will be paid twice a month (per *quincena*) upon presentation of a certification of accomplishments and rendition of actual services issued by the FIRST PARTY or it's duly authorized representative. The above payments will be charged to **Trust Fund 20201050-1.127** 

THAT this contract shall take effect May 1, 2025 until December 31, 2025 and may be renewed only upon recommendation of the head of the unit/department/office, duly supported with a copy of an evaluation report as to the quality of services rendered and quantity of the outputs delivered by the Job Order Worker for the period they were under contract of service by the university.

THAT the effectivity of this contract of services shall be subject to availability of funds and shall be deemed automatically terminated should the source of funds where this contract is charged is already depleted.

Confidentiality Clause: The SECOND PARTY is required to turn-over the data materials, equipment, and other things that come into his/her possession because of his/her job and preserve the confidentiality of any information regarding the University, faculty, staff, and students. Any disclosure and divulgement of confidential information (including personal information kept on computer or other media, research, technologies, and manuals) made unlawfully outside the proper course of duty will be grounds for dismissal without prejudice to filing of appropriate case in Court. The confidentiality clause will still apply even if the SECOND PARTY is no longer connected with VSU unless the University gives its express consent.

THAT this contract of service may also be terminated by the FIRST PARTY before the end of the stipulated term when the services is no longer needed or whenever the SECOND PARTY violates rules and regulations of the university or for unsatisfactory performance of the task assigned.

THAT this agreement will not in any manner result in any employer-employee relationship between the parties.
