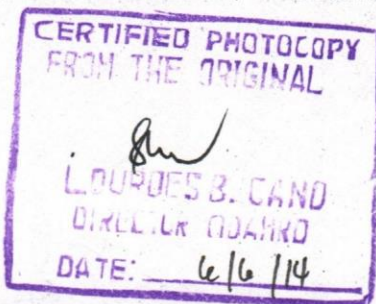

THE TESTS STILL DRAW BASIC KNOWLEDGES, SKILLS AND ATTITUDES IN THE TRADITIONAL MAJOR SUBJECT AREAS, I.E., FUNDAMENTALS OF NURSING INCLUDING PROFESSIONAL ADJUSTMENTS, MATERNAL AND CHILD NURSING, COMMUNITY HEALTH & COMMUNICABLE DISEASE NURSING, NURSING OF ADOLESCENTS, ADULTS AND AGED, AND MENTAL HEALTH AND PSYCHIATRIC NURSING.
- IN ORDER TO PASS THE EXAMINATION, AN EXAMINEE MUST OBTAIN A GENERAL AVERAGE RATING OF AT LEAST 75% WITH NO RATING BELOW 60% IN ANY SUBJECT. AN EXAMINEE WHO OBTAINS AN AVERAGE RATING OF 75% OR HIGHER BUT GETS A RATING BELOW 60% IN ANY GIVEN SUBJECT MUST TAKE THE EXAMINATION AGAIN BUT ONLY IN THE SUBJECT(S) WHERE HE/SHE RATED BELOW 60%. IN ORDER TO PASS THE SUCCEEDING EXAMINATION, AN EXAMINEE MUST OBTAIN A RATING OF AT LEAST 75% IN THE SUBJECT(S) REPEATED.
