1. Title of the Guideline

Conduct of entrance and annual medical examination

2. Objective

This document defines the system or process in the conduct of entrance and annual medical examination for students (VSU Integrated High School, undergraduate and graduate students.

3. Guidelines

- 3.1 All students shall register at the University Health Services, and must secure a medical/physical examination certificate duly signed by VSU Physician prior to enrollment.
- 3.2 All students shall undergo dental health examination prior to physical and medical examination.
- 3.3 All incoming freshmen and continuing students shall undergo an entrance medical examination and an annual medical examination.
- 3.4 Incoming freshmen shall submit a minimum Laboratory and Chest X-ray results prior to the conduct of medical examination. Other diagnostic procedures and specialty clearance may be required as the need arises.
- 3.5 Continuing students may be required of diagnostic procedures or specialty clearance as needed.
