The VISAYAS STATE UNIVERSITY (VSU), Visca, Baybay City, Leyte represented by the President of the University, DR. EDGARDO E. TULIN, VSU, Visca, Baybay City, Leyte;

MR. ILDE E. LOPEZ, of legal age, Pilipino and a resident of Zone 20, Baybay City, Leyte owner of Sports Utility Vehicle, KIA with Plate No. GHY521.

WITNESSETH

That the vehicle owned by herein operator will be given VSU sticker and allowed to enter the VSU campus by its purpose subject to their compliance of LTO Traffic Rules and **VSU Regulations**.

1. Sticker should be **placed** at the Up-Left Corner of the Windshield of the Vehicle(s).
2. **Always STOP** at the VSU Guard Post for inspection.
3. Observed speed limit of **20 kph** and road signs inside the campus.
4. **NO "Unnecessary"** blowing of horns and roaring of engine inside the campus.
5. **Car Stereo** should be **turned-OFF** while inside the campus.
6. **Give way** to hikers and bikers inside the campus.
7. **Observed Cleanliness** inside the campus by not allowing its commuters to throw outside the vehicles any food wrappers/trash but to **always place inside the vehicle a trash box**.
8. Show **respect** and **courtesy** to VSU Law enforcers and its commuters.
9. **Deal** and **Pick-up** passengers to the designated loading and unloading areas only.
10. **Make a report directly** to VSU Security Services Office any **abusive act drivers/operators**, stipulating names, Plate No. and the offense committed.

That failure of the driver/owner to follow hereto is a ground to impose the following penalties:

- First Offense - Cancellation of the Gate Pass and parking privilege for **one (1) week**;
Second Offense - Cancellation of the Gate Pass and parking privilege for **one (1) month**;
Third Offense - **Total Cancellation** of the Sticker/ Gate Pass and parking privilege.
