WITNESSETH

That the vehicle owned by herein operator will be given VSU sticker and allowed to enter the VSU campus by its purpose subject to their compliance of LTO Traffic Rules and VSU Regulations.

Sticker should be placed at the Up-Left Corner of the Windshield of the Vehicle(s).


