MS. MARY YVONNETTE C. NERVES, of legal age, Pilipino and a resident of Zone 8, Baybay City, Leyte owner of Sports Utility Vehicle, TOYOTA, Avanza with Plate No. ZTZ120.

WITNESSETH

That the vehicle owned by herein operator will be given VSU sticker and allowed to enter the VSU campus by its purpose subject to their compliance of LTO Traffic Rules and **VSU Regulations**.

1. Sticker should be **placed at the Up-Left Corner** of the Windshield of the Vehicle(s).
2. **Always STOP** at the VSU Guard Post for inspection.
3. **Observed speed limit of 20 kph** and road signs inside the campus.
4. **NO "Unnecessary" blowing of horns and roaring of engine inside the campus.**
5. **Car Stereo** should be **turned-OFF** while inside the campus.


